ADVICES FOR PARTICIPATION

1. HORSE HEALTH

I confirm with my signature that my horse is free from contagious illnesses and comes from a barn that is free from contagious illnesses.

2. SAFETY

Wearing a helmet is mandatory for kids and teenagers under 18d. Wearing of a helmet is encouraged and recommended for everyone.

3. STALLIONS AND YOUNG HORSES:

For safety reasons the participation with stallions and young horses is only possible after consultation with the trainer.

4. EQUIPMENT

The following equipment is recommended for each level:

Level 1: Rope halter, 3,7 m leadrope, carrot stick, savvy string

Level 2: additionally 7m rope, fitting saddle

Level 3/Level 4: additionally 14m lariat, feather lines and a second carrot stick , bridle without flash strap.

High quality equipment is influencing the effectiveness and refinement of the communication. When in doubt, just send a message and ask me.

Flash straps, martingales and any kind of side reins are not allowed in courses and lessons.

5. WEATHER:

The courses happen in any kind of weather. Please dress accordingly.

6. DOGS:

Foreign dogs are not welcome on all course locations, a prior confirmation with the barn owners is required if you wish to bring your dog along. It is recommended to leave your dog at home to be able to fully focus and concentrate on the horse and the horsemanship.

CONDITIONS FOR PARTICIPATION

1. WAIVER OF LIABILITY AND RELEASE

The organizers and the instructor Judith Kopf and Horsemanship Foundation Training assume no liability for personal injury including death, damage to animals or property or for damage to the personal equipment of the participants. Each participant is responsible for his/her own accident and liability insurance (including the use of horses owned by others). Participation in any activities, training sessions and courses associated with Horsemanship Foundation Training and Judith Kopf are undertaken at own risk.

2. MINORS

In the case of underage course participants, the legal guardian assumes all liability and declares Horsemanship Foundation Training and any organizer, instructor and staff to be exempt from liability.

3. PAYMENT

The course fee will be transferred to the specified account. If desired, an invoice can be sent by email. The course place is only firmly reserved after full payment of the fees. In the event of late payment, the course place cannot be guaranteed.

4. CANCELLATION

Private lessons must be clearly canceled 24 hours before the appointment, otherwise they are considered held and must be paid in full, including travel expenses. If private lessons are canceled no more than 48 hours before the start of the appointment, 50% of the costs are due.

A course place is firmly reserved after Judith Kopf has received the full course price. In the case of cancellations by course participants, the following rules apply if the course place cannot be completely replaced by other participants: Up to 30 days before the start of the course, the course price will be reimbursed at 100%, for cancellations up to 14 days at 50%. If you cancel less than 14 days before the start of the course, there will be no refund. Course participants are welcome to organize a replacement participant that has the appropriate level for the specific course.

5. CANCELLATION BY THE INSTRUCTOR OR ORGANIZER

The right to cancel courses at short notice if the number of participants is too low or for other important reasons is reserved. Course fees that were already paid will of course be 100% refunded. No liability is assumed for any inconvenience caused, nor is any compensation paid. A travel cancellation insurance is recommended.

6. VISUALS
